## I. EXECUTIVE SUMMARY

# I.I Background

The Greek Archives Project Committee was established in June 2009 (Academic Board minute reference 432.3.5), with a reporting line to Academic Board via the Library Committee.

# 1.2 **Summary**

The changed reporting requirements, as detailed in Attachment A, will increase the timeliness of decision-making by enabling the Greek Archives Project Committee to report directly to Academic Board, instead of via the Library Committee (which meets only 3 times a year) and will reduce the requirement for this Committee to meet regularly once the terms of reference are fulfilled. The composition is amended to include the Chair, Academic Board.

# 1.3 <u>Issues (including any financial, legal or compliance issues)</u>

None – this simplifies the reporting lines of the Committee.

## Terms of reference

- 1. To develop a framework and project specification to assess the current archives, artefacts, items from the museum etc., housed within what was the Hellenic Centre.
- 2. To advise the University on fund sources to resource such a project.
- 3. To seek Expressions of Interest and appoint/monitor academic reviews.
- 4. To propose possible co-location of associated collections/archives/activity.
- 5. To advise on maintenance of collection.
- 6. To review the process of digitizing materials and recommend on priorities and processes for digital availability of material.

## Reporting

The Committee will report to Academic Board <del>via the Library Committee</del>. This Committee is a special working group of the Board. It will meet on an as needs basis. It will be disbanded once its terms of reference are fulfilled.

Frequency of meetings
The committee will normally meet at least quarterly.

## Quorum

A quorum for a meeting of the Committee will be 50% of members plus one.

# **Budget**

Funding will be sought from the Greek community/existing funding historically allocated to the Hellenic Centre, with the approval of the donors and the La Trobe University Foundation.
