

## **HUMANITARIAN (ASYLUM SEEKER) SCHOLARSHIP**

### **Information to Applicants**

#### **Description**

These scholarships may be for an undergraduate degree or a postgraduate coursework degree and cover the tuition fees relevant to the program of study, for the duration of the study program. Applicants must be prepared to undertake full-time study unless exceptional circumstances exist. These scholarships are funded by La Trobe International.

#### **Eligibility**

1. Two scholarships are available each year for students who have been granted asylum seeker status by the Department of Immigration and Citizenship.
  - Should the scholarship holder's immigration status move from asylum seeker to permanent humanitarian protection visa during the course of the study program, the scholarship holder will become ineligible for the Humanitarian scholarship at the first census date after the humanitarian protection visa is gained. At that stage the scholarship holder could move to a HECS-Help payment arrangement.
  - Should the scholarship holder's immigration status move from asylum seeker to permanent resident during the course of the study program, the scholarship holder will continue to receive scholarship funds as no HECS-Help arrangement is available to permanent residents, nor are they eligible for a Commonwealth Scholarship.
2. The scholarship will be withdrawn if the scholarship holder does not pass all subjects each semester.

#### **Selection Criteria**

Scholarships will be awarded on the basis of academic merit and financial hardship.

#### **How to Apply**

Applicants must complete the attached scholarship application form, and write a 300 word statement of purpose detailing why they should receive the scholarship. Applicants must also complete the relevant La Trobe University undergraduate or postgraduate application form for **international students** applying for a university place.

#### **Assistance in Completing this Application Form**

#### **Application Closing Date**

Applications close on **15 December 2009** for the Semester 1 2010 intake. If you are currently studying your VCE your ENTER score should be provided to La Trobe International once it becomes available.
