LITERARY, DRAMATIC & MUSICAL WORKS PUBLISHED AS A PUBLISHED EDITION – includes journal articles, books, novels, poems, essays, short stories, song lyrics, journal articles, technical reports, tables, training manuals, instruction manuals, a choreographic show, a scenario or script for a cinematograph film; a table, or compilation, expressed in words, figures or symbols; a computer program or compilation of computer programs. The material does not necessarily have a ‘literary’ quality. ARTISTIC WORKS – means a painting, sculpture, drawing, engraving or photograph, a building or a model of a building, whether the work, the building or model is of artistic quality or not; or a work of artistic craftsmanship	ALL - NO NEED TO INQUIRE WHETHER SEPARATELY PUBLISHED OR COMMERCIALY AVAILABLE FOR PURCHASE *	ARTISTIC WORK WHICH IS ON A CD-ROM OR OBTAINED UNDER A SUBSCRIPTION LICENCE - USE OF THE MATERIAL MAY BE SUBJECT TO CONTRACTUAL TERMS AND CONDITIONS *
INCIDENTAL ARTISTIC WORKS - a map/photograph/drawing embedded in text and the text is also copied	ALL - NO NEED TO INQUIRE WHETHER THE ARTISTIC WORK IS SEPARATELY PUBLISHED OR COMMERCIALY AVAILABLE FOR PURCHASE *
