Role / Terms of reference
Terms of reference

1. To monitor compliance with health and safety legislative regulatory requirements and provide advice to the Senior Executive Group in relation to compliance.
2. To review and evaluate the University's overall performance in achieving the objectives set out in the University's health and safety strategies and policies and report to the Senior Executive Group.
3. To recommend to the Senior Executive Group for approval, all policies, standards, rules and procedures designed to promote a healthy and safe environment for employees, students, visitors and contractors.
4. To consider and review management and other reports on significant incidents (and overall incident trends and make recommendations to the Senior Executive Group regarding actions to prevent further occurrences.

5. To consider and review actions taken by management that may affect the health and safety of staff, students and visitors and make recommendations to the Senior Executive Group as appropriate.
6. To monitor the performance of, and provide direction to OH&S Consultative Committees.
7. To refer occupational health and safety matters to OH&S Consultative Committees for resolution, review or policy formulation.

Notes:

- i. The Committee at its discretion will invite attendance of a representative from each of the nominated OHS Consultative Committees. Representation of individual Consultative Committees will be nominated to attend on a rotational basis.
- ii. Additional Health and Safety representatives may attend, by invitation, on specific issues.
- iii. The NTEU is invited to nominate a representative to attend each of the OHS Consultative Committees.
- iv. Minutes of the most up to date meetings of the OH&S Consultative Committees should be provided to each Health and Safety Committee meeting.
- v. The Health and Safety Committee may from time to time hold in camera sessions, at which any attendance in addition to members will be at the express invitation of the Chair.
