

Prevention of Cruelty to Animals Act 1986

SECTION 32E

INSTRUMENT OF GRANT OF SPECIFIED ANIMALS BREEDING LICENCE

1. I, as the Manager Scientific and Pest Animals Licensing in the Department of Energy, Environment and Climate Action, pursuant to the power delegated to me by the Department Head under section 38(2) of the *Prevention of Cruelty to Animals Act 1986 (the Act)*, **hereby grant**, in accordance with section 32E of the Act, to the individual or organisation specified in the Schedule to this instrument a licence to cause or allow specified animals to be bred on the scientific premises specified in the Schedule.
2. This licence is subject to requirements set out in the Act and regulations made under the Act.
3. This licence remains in force until **17 September 2029**.
