

THE GEORGE AND LISL SINGER SCHOLARSHIP

What is The George and Lisl Singer Scholarship

Gary Singer and Geoffrey Smith wish to fund an undergraduate scholarship named after Gary's parents, George and Lisl Singer who migrated to Australia. Professor Singer was appointed the Foundation Chair of Psychological Science and as Director from the influential Brain-Behaviour Institute (BBRI) which he established in the School. During his distinguished career at La Trobe, Professor Singer received many honours. He was elected as a fellow of both the Australian Academic of Social Sciences and the American Association for the Advancement of Science. He received the Australian Cross (1st Class) for his contributions to science and was appointed as an Honorary Director of the Beijing Behaviour Research Institute.

How much is the scholarship?

\$7500 per year for up to three years paid in \$3750 instalments following confirmation of ongoing eligibility at Semester 1 and Semester 2 census dates (usually April and September).

If you receive the scholarship as a part-time student, you will be paid at the part time rate of \$1875 for each semester that you are enrolled part time.

Who is eligible to apply?

To be eligible to apply, you must:

- be an Australian citizen; permanent resident or holder of a humanitarian visa, who was not born in Australia;
- be intending to commence full-time or part-time study in an undergraduate or postgraduate coursework degree in Psychology* in 2018;
- be studying at any campus of La Trobe University;
- be experiencing financial disadvantage

How are the applications assessed?

The recipient of the Scholarship shall be selected by the University on the basis of:

- an application form addressing the eligibility criteria and including a personal statement detailing career goals and ambitions and a statement of financial situation (up to 500 words);
- evidence of financial disadvantage
- endorsement of the applicant by the donors.
- Preference will be given to applicants over the age of 21 years

Helpful information

- **Detailed information:** Make sure you provide full details requested in Sections 1, 2 and 3 of this application. Otherwise your application may not be assessed appropriately. All information will be treated with strict confidentiality.
- Supporting documentation: Supporting documentation is written verification from someone who is qualified to comment on your circumstances. The person must not be related to you or in a close personal relationship with you.
- False or misleading information: La Trobe University reserves the right to withdraw an offer of a bursary and re-assess the application if the University believes the recipient has provided false or misleading information in the application form or subsequently.
- Late applications: applications received after the closing date may be accepted by staff only if accompanied by a signed formal request outlining exceptional circumstances outside your control that have resulted in a late application, e.g. serious illness or other personal crisis. The selection committee will later determine whether or not a late application will be considered, based on the explanation you provide. (Note: Reasons relating to employment, placements, holidays or other activities that you choose to engage in are unlikely to be considered "exceptional".)
- Application process: the assessment will commence after the application closing date. You will be notified of the outcome via email approximately 2
 weeks after the application closing date. To ensure that all candidates are treated with equity, staff are unable to advice you of the progress of an
 individual application.

You may submit your completed application form via email or post only.

Confidentiality

All information provided by applicants will be treated as confidential. At La Trobe University, we respect the privacy of your personal information. We collect personal information in your application to determine your eligibility for a scholarship, bursary or grant, and to assess your application as part of the ranking and allocation process. In accordance with privacy laws, personal information about you contained in your application will not be used for any other purpose or disclosed to any person who is not part of the La Trobe assessment and allocation process, without your permission.
