# **Role / Terms of Reference**

# **Purpose**

As enunciated in the Terms of Reference.



#### **Terms of Reference**

- 1. To consider and advise the Academic Board on the University's entrance requirements, including prerequisites and English language requirements, for undergraduates and postgraduate coursework programs and monitor compliance with policies and procedures related to student admissions.
- 2. To approve and monitor new and existing course level articulation and credit transfer arrangements with TAFE and other domestic and offshore providers.
- 3. To consider admissions and selection policy matters related to the University's relationships with external stakeholders such as UAC, VTAC and DIICCSRTE.
- 4. To monitor the application and success of special entry access schemes.
- 5. To receive reports on external domestic and transnational pathways.
- 6. To monitor student admissions, retention, progression and success rates at course, college and campus levels as well as other cohorts identified by the Committee.
- 7. To provide reports to the Deputy Vice-Chancellor (Education) and Academic Board on retention, progression and success rates.
- 8. To make recommendations to the Board, on the development, adoption, implementation and review of relevant policies and guidelines.

### Reporting

The Committee will report to the Academic Board after each meeting.

#### Quorum

A quorum for a meeting of the Committee will be a third of the membership plus one.

### **Deputy Chair**

The Deputy Chair is normally appointed by the Committee from among academic members of the Committee and in the absence of the Chair, will assume the same rights and responsibilities accorded to the Chair, including attendance at Academic Board meetings to speak to the Report of the Committee.

#### Frequency of meetings

The Committee will normally schedule meetings four times per year.
