LTU Sport endorses and upholds gender-affirming practices to encourage and facilitate trans and non-binary participation in sport, sports research, fitness, and recreation in alignment with the following guidelines:

In accordance with the above guidelines, the Victorian Equal Opportunity Act, and the Sex Discrimination Act:

- For single-sex competitions, people can participate in the competition that best reflects their gender identity
- For mixed-gender competitions, people can participate in a manner that best reflects their gender identity. Rules for mixed-gender competitions will be applied based on gender identity
- Women with intersex variations can participate in women-only sporting competitions

- Within LTU Sport facilities, people have the right to use changing and bathroom facilities that best reflect their gender identity
- People participating in sports may wear the uniform of their choice as it aligns with their gender identity, so long as it abides by wider sporting code attire rules
- Collection of personal information will be conducted in an inclusive manner, and any information that is collected will be handled with confidentiality

The University is responsible for providing a safe, respectful environment and this means one that is free from discrimination and harassment. Trans and Gender-based harassment and discrimination (including verbal, physical, direct, indirect, and casual discrimination) will not be tolerated. To ensure that the University can remain a safe environment for all, we encourage reporting of behaviour that is harmful and disrespectful by victims or witnesses.
