# Rapid review for WHO on communication for physical distancing

In 2020, we were invited by the World Health Organization's (WHO) Regional Office for Europe to conduct a rapid review of the evidence addressing this question: What are relevant, feasible and effective approaches to promote acceptance, uptake and adherence to physical distancing measures for COVID-19 prevention and control?

We accepted the challenge. This type of broad question – and the fact WHO wanted the review done very quickly – meant that we looked for the evidence in the 'upstream' documents where all types of research and expert opinion has been already collated and synthesised – namely guidelines and systematic reviews. Our job, then, was to analyse these documents and present the key themes. The resulting report is <u>published here</u>.

The report has a lot to say and recommend in terms of approaches. Consistent features of effective communication include clear, consistent and actionable content; attention to the timing and currency of messages; consideration of the audiences for communication within and across populations; and deliberate considerations of tailoring and equity to ensure diverse population groups are reached and existing inequalities addressed.

These lessons will continue to be highly relevant as Australia combines a vaccine roll-out alongside continuing outbreaks and variants, as well as opening up nationally and internationally. It is a silver lining in a dark cloud that governments have re-discovered the critical importance of public communication.

The team was led by Dr Rebecca Ryan and she was joined by Centre staff - Anne Parkhill, Lina Schonfeld, Louise Walsh, Dianne Lowe, Bronwen Merner, Nami Nelson and Sophie Hill. Rebecca will be updating the review as a Cochrane rapid review in 2021-22 with a large team.


We plan to continue learning about and testing what are called rapid methods for evidence synthesis and we plan to incorporate this into our Cochrane work.





The WHO invitation for rapid review advice in pandemic communications challenged the standard searching procedures that we had used previously for our systematic reviews. We needed evidence about a virus and a disease that had only been understood for a matter of months and where little had yet been researched, documented or written. The skills that we developed to respond to the new information context involved finding and authenticating new databases and sources to use in conjunction with our standard peer-reviewed sources, including identifying articles ahead of print, applying machine learning tools to prioritise references for screening and regularly updating the searches as new data was published (moving towards living searching methods). We will take these new skills into our work for newer review formats, including rapid Cochrane reviews, that we are planning.

Our goal of getting evidence into policy and practice means that we are keen to try and get the outputs of synthesis efforts out into the community much faster than before. With critical public health communication challenges happening all around us, this seems like a good goal to have!

### Piloting shared decision making in Victoria

To support Victorian health services implement shared decision making, Safer Care Victoria commissioned a pilot project to be managed by our Centre, in collaboration with decision aids expert, Professor Dawn Stacey, University of Ottawa. The project focused on capacity building through training and provision of ongoing technical support and guidance while pilot sites moved forward with implementing shared decision making, including the development of a decision aid.

The project began in November 2019 with a Masterclass in shared decision making presented by Professor Stacey for 23 health services and Safer Care Victoria staff. Professor Stacey then held a workshop on Implementing shared decision making for eight health services that were invited to participate in the project as pilot sites.

A follow up workshop on implementation was held in March 2020. This workshop focused on supporting each site to continue development of plans for decision aid development and putting shared decision making into practice. The workshop was held just prior to the widespread travel restrictions and other limitations that were instigated as part of the COVID-19 pandemic response in Victoria.

The project was designed to provide technical support, guidance and feedback to services as they planned and implemented shared decision making and their decision aid development process. One of the strengths of the project was that it was designed as an iterative program. This meant the approach and content of support provided to pilot sites was able to be adapted to different site needs based on emerging evidence, observations and learning.

This approach was also a significant strength in being able to adapt to the changing COVID-19 context throughout the implementation period in 2020. The changing restrictions, shifting priorities and staffing redeployment at health services linked to the COVID-19 response in Victoria meant health services paused or delayed their shared decision making activities. By the project end, two original sites were able to progress their planned work to draft decision aids, three new sites were added to the project to receive tailored support and a website was created as an online resource hub for implementing shared decision making. Despite the disruptive year, the project was able to complete most planned activities, incorporate new activities to adapt to the changing circumstances, and expand the scope of support to include new sites. As a result, the project was able to generate valuable insights that were incorporated into an online short-course on Person centred care through shared decision making launched in 2021.

## Translating research into policy and practice

# Leading contribution to consumer and community information for Voluntary Assisted Dying

In June 2019, Victoria became the first state in Australia to introduce Voluntary Assisted Dying.

Bronwen Merner and Sophie Hill were privileged to be part of the Community/Consumer Information Guidelines Working Group of the Voluntary Assisted Dying Act Implementation Taskforce, Department of Health and Human Services Victoria. The Working Group was chaired by Mary Draper AM. Bronwen Merner led the development of the information for consumers and community members, applying coproduction methods and user testing. Bronwen also presented with Mary Draper in May 2019 at the Victorian Voluntary Assisted Dying Implementation Conference.

The final information was released in April 2019 and is accessible here.

#### Guide to producing and sourcing quality health information

Guidelines to support high quality health information for consumers and carers in Victoria, developed by the Centre, were released April 2019 at the highly successful Partnering in Health Forum, run by Safer Care Victoria. The Guidelines were developed to support innovation and improvement in the Communication domain of Safer Care's Partnering in Health Framework. Louisa Walsh and Sophie Hill ran a workshop for health service staff at the Forum and focused on challenges and solutions.

There are four Guidelines, addressing governance, partnering with consumers, health literacy and reducing duplication. The importance of each Guideline is explained, followed by a list of key tasks that contain advice and comprehensive supporting information.

The Guidelines are paired with a Self-evaluation Toolkit that are workbooks containing reflective questions and an activities checklist. Additionally, in the Toolkit, each Guideline has been mapped against the National Safety and Quality Health Service Standards.

#### Escalating care when health is deteriorating

Safer Care Victoria asked the Centre to review the evidence on how to strengthen opportunities for patients, carers and family members to escalate care in Victorian health services.

A rapid review was completed by Nami Nelson with assistance from Rebecca Ryan and Anne Parkhill and informed Safer Care Victoria's planning for piloting HEAR Me, a 24/7 consumer-initiated escalation service in Victorian hospitals.

Next, Bronwen Merner and Sophie Hill undertook a process evaluation to explore consumers' and health professionals' perceptions and experiences of HEAR Me across 17 Victorian health services from 2019-2021. The evaluation also sought to identify the main enablers and barriers to the implementation of HEAR Me to inform a potential state-wide roll-out.

The evaluation was greatly impacted by the COVID-19 lockdown but, regardless, one patient and 19 HEAR Me champions, ward staff or call takers participated in this evaluation, engaging in one-off, individual phone or Zoom interviews.

We are very grateful for the health services who participated in the evaluation and the clinicians and patient who agreed to be interviewed. This happened at the end of the Victorian lockdown period, a weary time for all. The report to Safer Care Victoria was presented in April 2021.

### Engaging consumers as stakeholders in research

#### **Optimise Community Engagement Group**

Early in the COVID-19 Pandemic, we were approached by Professor Margaret Hellard, Deputy Director of the Burnet Institute, to join the Optimise study, a partnership of the Burnet and Doherty Institutes in collaboration with University of Melbourne, Swinburne University of Technology, Monash University, Murdoch Children's Research Institute, the Centre for Ethnicity and Health, and the Health Issues Centre.

As a result, La Trobe University became a collaborator in this ground-breaking and exciting project in the midst of the pandemic.

Optimise stands for Optimising Isolation, Quarantine & Distancing for COVID-19, and the project aims to find out how Victorians are experiencing COVID-19 and responding to the measures introduced to stop the spread of the virus.

This invitation led to the formation of a Community Engagement Group, a group of seven people who met monthly during 2021 to understand how community leaders and consumer representatives interpret the Optimise evidence in the context of their own communities and to hear from members about how the Optimise evidence should be translated into communication or resources that will meet community needs. The views and recommendations of the Community Engagement Group are included in a monthly report of the Optimise Study findings that is sent to government and non-government stakeholders. #### Consumers and clinicians in partnership with our PhD students

Louisa Walsh is undertaking a PhD supported by a National Health and Medical Research Council Scholarship.

The aim of her research is to explore the potential for social media to be used for greater and more meaningful involvement by the public, patients and family members in service improvement activities within Australian public hospitals.

The research is being conducted within a utilisation-focused participatory research methodology. The research is guided by the involvement of an advisory committee of stakeholders, which includes three healthcare consumers and three healthcare providers in clinical and non-clinical roles. Members of the advisory committee have been involved in a range of research activities, including determining research questions and methods, testing data collection tools, recruiting participants to studies, analysing data and co-authoring publications.

In 2019, Louisa completed the first study of her PhD - a scoping review of the international literature around the use of social media as a tool for stakeholder engagement in change and improvement in health organisations. In 2020, Louisa completed the second study of her PhD - interviews with Australian public hospital stakeholders about the use of social media to engagement consumers in service design and quality improvement. She has submitted four papers based on these two studies, which she hopes will be published in 2021. To keep up with her research and publications, head to the dedicated project webpage.

#### Broadening and deepening consumer engagement in guidelines

Anneliese Synnot is a Research Fellow at the Centre and completing her PhD, supported by a National Health and Medical Research Council Scholarship.

In early 2020, Annie commenced the final two studies of her PhD, in work that was partly funded by the Stroke Foundation. The aims were to identify principles, methods or approaches to (a) broaden the diversity of consumers involved in developing guidelines and (b) deepen the engagement of consumers involved in guidelines, in terms of the ways that they can contribute and the tasks they can undertake. Annie conducted companion scoping reviews (one focussed on deepening, the other on broadening) and interviewed consumers and guideline developers. Two manuscripts are currently being finalised for journal submission.



#### Cochrane Consumer and Communication reviews featured on Cochrane Library app

Interventions to increase patient and family involvement in escalation of care for acute lifethreatening illness in community health and hospital settings by Mackintosh et al. was selected for inclusion in the January 2020 edition of the Cochrane Library App.

Interventions for involving older patients with multi-morbidity in decision-making during primary care consultations by Butterworth et al. was selected for inclusion in the special edition of the Cochrane Library App curated by Cochrane Campbell Global Ageing Partnership in December 2020.

#### Cochrane authors with high profile reviews

Professor Dawn Stacey and colleagues' Cochrane review, Decision aids for people facing health treatment or screening decisions, was the highest cited review in the Cochrane Database of Systematic Reviews, cited 271 times in 2019.

#### Inclusion of Cochrane reviews in international guidelines

From 1 January 2018 to 30 June 2020, 26 Cochrane Consumers and Communication Reviews were cited across 61 national and international clinical practice guidelines.

The five reviews most highly-cited were:

- Decision aids for people facing health treatment or screening decisions by Stacey et al. (cited in 23 guidelines)
- Interventions for enhancing medication adherence by Nieuwlaat et al. (cited in 18 guidelines)
- Personalised care planning for adults with chronic or long-term health conditions by Coulter et al. (cited in 6 guidelines)



- Self-management education programmes by lay leaders for people with chronic conditions by Taylor et al. (cited in 5 guidelines)
- Interventions to enhance adherence to dietary advice for preventing and managing chronic diseases in adults by Desroches et al. (cited in 4 guidelines).
