Impact of COVID-19

Still on the issue of COVID-19. Professor Christine Bigby is Chief Investigator of the Australian arm of a new international study investigating the impact of COVID-19 on people with intellectual disabilities, their families and service providers. Dr Tal Araten-Bergman from LIDS is also involved in the study and will lead the Israeli arm of the project, while LIDS adjunct Professor Magnus Tideman will lead the Swedish arm. The project, titled the Impact of COVID-19 on Individuals with Intellectual and Developmental Disabilities and Caregivers, is led by Professor Christine Linehan, University College Dublin, and funded by the Irish Health Research Board.

The project involves researchers in Ireland, the UK, the USA, Netherlands, Zambia, Czech Republic, India and Norway. The group will develop an online survey for caregivers around the world that will ask about symptoms, access to treatment and equipment, and the impact of social distancing measures during

the pandemic. The global findings will be used to draft policy and practice guidelines on how best to support people with intellectual disabilities, their families and support services during pandemics and other natural disasters.

Other new projects in 2019

We are pleased to announce that the Living with Disability Research Centre has embarked on two other new projects this year. Each project varies in scope and focus, but each is an example of the way in which our Research Centre works across an exceptional array disciplines and themes.

Increasing hospital access and quality care for people with cognitive disability

Funding: Information, Linkages and Capacity Building (NDIS)
Professor Teresa Iacono, Professor Christine Bigby, Professor Jacinta Douglas and Dr Jo Spong

This project translates research evidence about the quality of hospital care for people with cognitive disabilities in Victoria to build mainstream health service capacity. The project brings together regional and metropolitan hospitals and disability services. Key activities are the trial and evaluation of multi-media training for patients, families, disability support workers and hospital staff to improve hospital care and the experiences of adults with cognitive disabilities. This work is particularly timely in light of the particular health vulnerabilities of

people with life-long or long term disabilities in the current COVID-19 environment.

Measuring organisational factors that sustain good quality support

Funding: Lorna Hodgkins Foundation

This study builds on earlier research conducted by the Research Centre about the organisational factors needed to embed Active Support and Practice Leadership in services. It will develop a new scale to measure these factors and test its psychometric properties. The La Trobe Unisson Scale will provide a means to measure organisational factors that potentially contribute to good quality support. The scale could be used in research to examine the extent to which organisational factors are associated with the quality of Active Support. The findings from this research could also be used by people with disabilities and their families to inform decisions about purchasing services from organisations. The study will involve interviews with senior managers from disability support organisations across Australia.

Royal Commission

The Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability held public hearings in Melbourne in early December 2019. The Melbourne public hearings were concerned with housing, particularly homes, for people with disability in Victoria.



Professor Christine Bigby made a submission on the final day of the Melbourne public hearing. Her submission drew on more than ten years of research into

accommodation services for people with intellectual disability. It covered a variety of themes, from the important role that Active Support plays in ensuring people with intellectual disabilities are more engaged and have a better quality of life, to the links between leadership and good culture in group homes.

Local Solutions Forum

In February this year, approximately 60 representatives from Rural and Regional NDIS providers, tertiary training organisations and others came together at La Trobe University in Bendigo for a forum organised by the Regional Allied Health Disability Workforce working party. Convened by Professor Teresa Iacono, the forum was primarily focused on growing and supporting allied health student placements and mentoring graduates working with people with disability across rural and regional Victoria.



By bringing together stakeholders from Victoria and other states concerned about building a quality regional and rural allied health NDIS workforce, the forum provided opportunities for conversations between industry and training organisations, and others concerned about meeting the needs of people with disability accessing NDIS funded supports.

The information gathered through this forum will be used by the Regional Allied Health Disability Workforce working party to consider next steps in their work, with the intention of drawing on the network of people and organisations who were present at the forum on the day.

Visiting Scholars

Before the COVID-19 pandemic took a grip in Australia, the Living with Disability Research Centre played host to two Visiting Scholars at opposite ends of their academic careers. Last year, in November, Associate Professor Phylis Wong, Chinese University of Hong Kong, visited our Research Centre for two of weeks. Then, in February this year, Per Arvidsson, PhD Candidate, Malmo University, Sweden, joined us for more than a month. While they were here, Dr Wong and Arvidsson each shared and developed their work, and also contributed to the vibrant community of scholars here by providing thought provoking presentations at our Research Seminar Series. It was a pleasure hosting Wong and Arvidsson and it offered us an opportunity to share our expertise and explore opportunities for further collaboration.





Research Seminar Series



We have put together a well balanced programme of established and emerging scholars for our 2020 Research Seminar Series. In February, we kicked off the year with a wonderful presentation by Dr Lincoln Humphreys on Practice Leadership and the important role it plays in ensuring Active Support remains embedded in accommodation services for people with intellectual disabilities. And in March, Dr Sian Anderson provided a fascinating insight into twitter responses to the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability.

We were forced to put our Seminar Series on hold for a while, due to COVID-19 pandemic, but we have since moved to an online format that will allow us to continue our Seminar Series while Victorian social distancing measures remain in place. It was great to see that there was really strong interest in our first online Webinar in May, when Professor Christine Bigby and Dr Clarie Spivakovsky delivered presentations on issues of risk and dedifferentiation for people with intellectual disability.
