Research Dissemination

Research report for the Royal Commission into Violence, Abuse, Neglect and Exploitation of LGBTQA+ people with disability

LGBTQA+ people in Australia have consistently reported higher levels of violence, harassment and abuse and poorer physical and mental health than the general population. In turn, LGBTQA+ people with disability experience substantially greater challenges and poorer outcomes than LGBTQA+ people without disability, including experiences of violence, abuse and neglect.

LiDs Director Christine Bigby is one of the authors of a new research report that has been prepared in collaboration between the Australian Research Centre in Sex, Health and Society (ARCHS) and LiDs for the Royal Commission into Violence, Abuse, Neglect and Exploitation of LGBTQA+ people with disability. This work comprised a secondary analysis of data from two national surveys on the health and wellbeing of LGBTIQA+ people in Australia, one which focused on young people aged 14-21 and the other on adults aged 18 and over. In many instances, large majorities of LGBTIQA+ people with disability reported experiencing violence, abuse, neglect or exploitation. Experiences of abuse were also reported in relation to service systems, in intimate relationships and families. Adults categorised with more severe disabilities appear to be at even higher risk of abuse and a host of negative outcomes.

ARCHS Director Associate Professor Adam Bourne will conduct a seminar on

FASD Awareness Month

Every September is International Fetal Alcohol Spectrum (FASD) Awareness Month. FASD is a neurocognitive disability with a prevalence rate higher than well-recognised conditions such as Autism and Down Syndrome. However, professionals in health, social service, disability and education report that they know little about it. Australia has a National FASD Strategic Action Plan but at present does not have national FASD prevalence data, and there is general agreement among researchers and practitioners that rates are underestimated.

LiDs researcher Dr Kerryn Bagley is co-chair of the Victorian FASD Special Interest Group (VIC FASD SIG), which arranged a number of FASD awareness events and activities throughout the month. Our September LiDs Seminar was part of this programme, and featured presentations from Dr Bagley as well as FASD Parent Advocate Ms Angelene Bruce and Professor Anita Gibbs from the University of Otago, NZ.

2022 ASID Conference

A number of our researchers presented at the 2022 Australasian Society for Intellectual Disability (ASID) conference, which was held virtually across two days on 4 and 9 November. LiDs director Professor Christine Bigby is also the current president of ASID.

The theme of this year's conference was "Inclusion – being there, being involved and being valued", and featured keynotes and sessions delivered by researchers, service providers, policy and advocacy practitioners, self-advocates and family members of people with intellectual disabilities. LiDs researchers Prof. Christine Bigby, Prof. Teresa Iacono, Dr Jo Spong, Adjunct Prof. Jennifer Clegg, Dr Kerryn Bagley, Dr Sian Anderson, Dr Tal Araten-Bergman and Dr Carmit-Noa Shpigelman all contributed presentations.

2022 NR-SIG-WFNR Conference

Several LiDs researchers presented at the 19th Conference of the Neuropsychological Rehabilitation Special Interest Group of the World Federation for NeuroRehabilitation (NR-SIG-WFNR) in October. This was a a hybrid conference heled online and in-person in Maastricht, Netherlands. The NR-SIG is for clinicians and researchers in a multitude of disciplines interested in the rehabilitation of people across the lifespan with cognitive, emotional, psychosocial and behavioural deficits caused by acquired brain injury or neurological disease (both progressive and nonprogressive). LiDs researchers Em. Professor Jacinta Douglas, Dr Megan Topping, Dr Di Winkler and Ms Rebecca Leeson contributed presentations.

Particular focus was given to Specialist Disability Accommodation (SDA).


