







### **BACKGROUND**

Autism is a neurodevelopmental condition that affects how individuals communicate, interact, and engage with the world around them. These differences include social communication challenges, repetitive behaviors, intense interests, and unique sensory experiences.

Autism can have significant impacts on learning, communication, and behaviour. Many children will meet the criteria for multiple diagnoses and are susceptible to poor mental health during their school years and beyond, reducing their own and their family's wellbeing across the lifespan.

## THE GAP

Early diagnosis of autism is crucial for ensuring that children receive the support they need to thrive. Although early diagnosis, especially before age two, leads to better outcomes, fewer than 3% of Autistic children in Australia are diagnosed this early. Significant barriers include long waitlists, high costs, and a shortage of trained professionals.

## THE SOLUTION

Expanding our low-cost, neurodiversity-affirming, evidencebased, neurodevelopmental assessment clinic.

# The Victorian Early Assessment Clinic

We are closing the gap with the Victorian Early Assessment Clinic's five-step multidisciplinary, combined telehealth and in-clinic assessments. Backed by the Victorian Government, we launched in October 2023 as part of the Victorian Autism Plan. The VEAC team sees families two days per week, averaging 2.5 weekly assessments.



## AIMS, PROGRESS AND TIMELINE



To provide an affordable, comprehensive neurodevelopmental assessment within a neurodiversity-affirming practice model to families of children under 3 years of age with a high likelihood of autism in Victoria.

Establish the clinic: employ Psychologists,
Occupational Therapists, a Speech Therapist, a
Clinic manager and an intake officer and train
them in neurodiversity-affirming practice. Train
clinicians in the diagnosis of autism (2023).



Expand operations to five days per week at the Bundoora campus of La Trobe University (2025-).



## POTENTIAL FOR IMPACT

- Build capacity in early primary health workers to identify neurodevelopmental differences (NDD) in children under 3 years of age.
- Improve access to diagnostic services for families in regional and remote areas of Victoria by fostering stronger ties with rural and regional communities.
- Reduce diagnosis costs for Victorian families, making it more accessible and affordable.
- Contribute to developing Australian Government guidelines for autism-friendly service design and delivery.
- Improve models of diagnostic services to ensure more efficient, accurate, and timely assessments.
- Improve long-term outcomes for children and their families by strengthening early identification and support access.
- Support evidence-based policy changes to improve autism diagnosis and care across the lifespan.
